Introduction:

Information We Collect:

DENNY FAMILY DENTISTRY may collect certain information when you access or use the Website. This information may include location information, IP address, device identifier, browser type, domain name, operating system, information about your use of the Website, internet service provider, pages that you visit before and after using the Website, the date and time of your visit, information about the links you click and pages you view within

the Website, and other standard server log information. We may use various tools such as cookies, web beacons, and other online tracking technologies to collect this information. We may combine certain automatically collected information with additional information we obtain about you, which may include information we obtain from third parties. We collect your information from the following sources:

- Information you give us, such as during registration on the Website, Website interactions, such as rating products, joining a forum, subscribing to notifications, customer service operations, purchasing, scheduling, surveys, downloading a software update, registering for an event, transact or otherwise communicate with us through the Website;
- Information from other sources, such as companies that help us to update our records; and

Cookies and Other Technologies

DENNY FAMILY DENTISTRY's Website, online services, interactive applications, email messages, and advertisements may use various technologies, now and hereafter devised, that automatically collect certain Website usage information whenever you visit or interact with the Website.
